# **1. Introduction**

Williams Lake First Nation (the “Organization”) is issuing this Request for Interest (RFI) to invite qualified insurance brokers and/or insurers to express their interest in providing insurance services to the Organization.

This RFI is for information-gathering purposes only and does not constitute a commitment by the Organization to procure insurance services or to proceed with any respondent.

## **2. Scope of Interest**

The Organization is seeking expressions of interest for one or more of the following lines of insurance coverage, as applicable:

- Property Insurance
- Accidental Death and Dismemberment
- Commercial General Liability
- Directors and Officers (D&O) Liability
- Professional Liability / Errors and Omissions
- Cyber Liability
- Automobile / Fleet Insurance
- Crime
- Business Interruption
- Glass
- Equipment
- Golf Course
- Other related or complementary insurance products

Respondents may express interest in providing all or part of the above coverage.

- Summary of key client segments served
- Any relevant specializations

### **3.3 Coverage and Capabilities**

- Lines of coverage offered
- Geographic coverage and licensing
- Capacity and underwriting appetite relevant to the Organization

### **3.4 Service Model**

- Account management and servicing approach
- Claims handling and advocacy process
- Risk management or loss prevention services (if applicable)

### **3.5 Value-Added Services**

- Technology platforms, reporting tools, or analytics
- Benchmarking, advisory, or consulting services
- Any other differentiators
